TERMS AND CONDITIONS

Contract A contract shall be deemed to have been made between Jim Barker and the booking client (the client) when the client has confirmed requirements by e-mail, letter, written order form or telephone and Jim Barker has accepted such a booking.

Payment Jim Barker will accept **CASH, CHEQUE** or **BACS** Payment. It is the customers responsibility for clear funds to be made available for payment.

Deposit A non-refundable deposit of 25% of the overall price of the booking must be enclosed with the return of this form, unless the booking is accepted within 30 days of an event in which case the full amount must be paid immediately.

Payment of Balance The balance of the overall price must be paid not less than 30 days before the date of the event.

Consequences of Failure to Pay If payment is not paid within the time limits as above, this will be in breach of contract by the client entitling Jim Barker to treat the contract as at an end, and re-allocate bookings without informing the client. In the event of Jim Barker treating the contract as at an end under clauses above Jim Barker shall be entitled to all sums already paid by the client. The balance, if any of the cost/price of the booking should become immediately payable by the client to Jim Barker

Cancellations or Variations by the Client Any notice of cancellation by the client of a booking or part of a booking must be made in writing by letter (please obtain Proof of Posting) to Jim Barker, 26 Campfield Street, Falkirk FK2 7DN or email to jim@jimbarker.net. Cancellations must be 30 days prior to the event in order to receive a refund minus a booking fee Any request by the client for a variation to a booking must be made in writing by letter (please obtain Proof of Posting) to Jim Barker; 26 Campfield Street, Falkirk FK2 7DN or email to jim@jimbarker.net..

Consequences of Cancellation by the client If a booking or part of a booking is cancelled by the client more than 60 days before the event the client shall be liable for 50% of the total price of the booking. If the client cancels the booking or part of a booking less than 60 days before the event the client shall be liable for the total cost of the booking.

Force Majeure If a performance is prevented, rendered impossible or infeasible, by sickness, inability to perform, any act or regulation of any public authority, civil tumult, strike, epidemic, interruption in or delay of transportation services, weather, war conditions, acts of terrorism or emergencies or any cause beyond the control of Jim Barker, it is understood and agreed that there shall be no claim for damages by either party to this Agreement and Jim Barkers obligation as to such performance shall be deemed waived Provided, however, if such inability is caused or contributed to by the client, the clients obligation to make payment as above shall not be waived and the client shall be liable for the amount due and owing to Jim Barker
